Donald Trump pagou uma multa de US\$ 175 milhões por fraudar balanço financeiro. O ex-presidente dos Estados Unidos, Donald Trump, pagou uma multa de US\$ 175 milhões (R\$ 884 milhões) após ser condenado por fraude fiscal pela Justiça de Nova York. A multa foi reduzida em vegas sports sga bet 60% após a Justiça aceitar uma apelação feita pela defesa de Trump.

Segundo a acusação, Trump e vegas sports sga bet empresa, a Trump Organization, fraudaram balanços financeiros por mais de uma década para obter empréstimos e negócios em vegas sports sga bet melhores condições. O ex-presidente negou as irregularidades e afirmou que a ação é um caça às bruxas com motivação política.

A procuradora-geral de Nova York, Letitia James, processou Trump e a Trump Organization em vegas sports sga bet setembro de 2024. Ela acusou o ex-presidente e a empresa de mentirem durante uma década sobre valores de ativos para obter melhores condições em vegas sports sga bet empréstimos bancários e seguros.

A procuradora also said that the inflated assets included Trump's Mar-a-Lago property in Florida, his penthouse apartment in Trump Tower, and several office buildings and golf courses.

Trump argued that he could not pay the original amount of the fine, which was US\$ 454 million (R\$ 2.3 billion). His lawyers also argued that the fine was excessive and proposed to pay a smaller amount, US\$ 100 million (R\$ 501 million), or to suspend the payment.

The lawyers also tried to find companies that could provide financing for the payment, but they were unsuccessful. Gary Giulietti, an executive specialized in insurance, was hired by Trump to try to find a company that could provide the financing. However, Giulietti said that finding a company that could provide a US\$ 454 million loan was impossible under current circumstances. In a separate case, the Justice of New York ordered Trump to stop attacking the family of Judge Juan Merchan, who is analyzing another case involving Trump, involving adult film star Stormy Daniels. Trump had called the judge's daughter a "rabid Trump hater" in a social media post, and prosecutors argued that Trump was trying to intimidate potential witnesses in the case.

The Justice also ordered Trump to pay a fine of US\$ 100,000 (R\$ 501,000) for contempt of court after he violated an order not to talk about the case.

In another development, the government of Brazil has announced that it will appeal a court ruling that found that the government's financial disclosure law is unconstitutional. The law, which was enacted in 2024, requires public officials to disclose their assets and income. The court ruled that the law violates the constitutional right to privacy.

The government argues that the law is necessary to prevent corruption, but the court said that it violates the privacy of public officials and does not provide sufficient evidence to justify the violation of their rights. The government plans to appeal the decision to the Supreme Court.

Parliamentary leader warns of impeachment against Temer

The leader of the lower house of Brazil's congress, Arthur Lira, said that there are enough votes to impeach President Michel Temer if he does not veto a bill that reduces the independence of the central bank.

Lira said that Temer has the opportunity to veto the bill and avoid an impeachment process, but if he does not, there are enough votes to impeach him.

The bill, which was passed by Congress, reduces the independence of the central bank and gives the government more control over monetary policy. The bill is seen as a blow to the independence of the central bank and has sparked concerns about the government's ability to intervene in the economy.

The chairman of the central bank, Roberto Campos Neto, said that the bill could harm the bank's ability to control inflation. He also warned that it could lead to a crisis of confidence in the

economy.

The government argues that the bill is necessary to stimulate economic growth, but opponents say that it is a threat to the stability of the economy.
